Proposal to strike the numerical limit of swimmers on swims (60 swimmers for most and 75 for GG and Alcatraz) and replace it with a safety ratio rule. Scheduled Dolphin Club out of cove swims require a 3:1 swimmer-to-pilot/craft ratio. Pilots are considered individuals who accompany swimmers in human-powered watercraft (i.e. rowboat, kayak, paddleboard, etc.). Two people in one human-powered watercraft are considered one pilot, which covers three swimmers. Motorized craft are not included in the 3:1 swimmer-to-pilot ratio.

Motion: _CC_/_LL_ Approve striking the numerical limit of swimmers on scheduled out of cove swims and replacing it with a safety ratio rule: require a 3:1 swimmer-to-pilot/craft ratio. Pilots are considered individuals who accompany swimmers in human-powered watercraft (i.e. rowboat, kayak, paddleboard, etc.). Two people in one human-powered watercraft are considered one pilot, which covers three swimmers. Motorized craft are not included in the 3:1 swimmer-to-pilot ratio.
