On May 18, Meg submitted comments on behalf of the Dolphin Club on BART's Initial Study conducted for creating a pedestrian only zone at the end of Jefferson Street and running the MUNI line to the current location of the Bocce Ball courts.

**10. PRESIDENT: Reuben Hechanova –**

Colin Gift presented a proposal to photograph the Dolphin Club boats for a visual record in case a fire. He sent around a show a flipbook binder of photos as a model to the board this meeting. The cost estimate is: \$50/hour with a 4 hour cap per boat – 16 wooden boats = \$3,500. Schedule: he proposes to start in the fall. Rick mentioned that we need to discuss what budget would fund this activity. Some should come out of Joe's budget since one of the goals of this project is insurance related. Rueben proposed including CADD work. We should vote on this in one of the next board meetings. Diane will put a proposal together.

Tom Keller presented a proposed Baykeeper fundraising dinner at DC on Saturday, September 10, 2011 with a suggested start time of approximately 6pm. In order to continue our close relationship with Baykeeper, members Jeff Russell, Peter Molnar, Tom Keller and others would like to host a dinner in support of Baykeeper. They propose we support their efforts which include our interests and celebrate their second annual Transbay Relay on September 10<sup>th</sup> in which several 'phins participated last year. Details are being worked out and will be presented at the next board meetings. In general, this dinner will look and taste like the many dinners we've held in the past in celebration of Baykeeper and the Bay. He proposed that we sell as many as 200 tickets, at approximately \$50/head, with donated food and drink. Thirsty Bear Brewing Company will donate kegs and Blue Mermaid will possibly donate chowder.

**20. TREASURER: Rick Avery – Presented monthly financial report. We are in really good shape financially.**

**21. BOAT CAPTAIN: Diane Walton – Presented Boat Committee report. 1) Fleet – Kupuna being worked on, 2) Budget, 3) Wieland Relaunch will be on July 23, 4) DC-SERC Triathlon. Diane presented list of boats and what they are insured for – she is working on updating the values. Reuben will hold Rowing Training next Saturday from 9-3pm.**

**22. HOUSE CAPTAIN: Joe Gannon - Discussed the following: (1) Reserve Money Study – spent the last 3 months on what repairs need to be done at the Dolphin Club and associated costs through 2020. We will need approximately \$175K. Bottom line – we need to increase the budget for maintenance. Rick will work with Joe to double budget for next year – increase from 26K to 52K. (2) Fred Johnson is working on recommendations for the Staib Room TV replacement. He has 10 TVs he is looking at all Energy Star 32-48”. He proposed that the board vote by e-mail and then ratify – he will buy before the next meeting. He recommended making a motion for between \$1,200 and \$2,500. 3) Daniel Constantine asked if he could do an Energy Audit report. He will do this with Bill for no charge. 4) Staib Room Deck report – Building Committee recommends limiting number of people walking on this at one time. It does not meet seismic standards. Let's not invest in renovating it now because it might be part of a bigger project. We should limit access to prevent liability/risk. Discussed putting up a more permanent sign: “no more than 6 people at a time”.**
